COVID-19 Vaccine Exemption - Medical Accommodation Form

This form incorporates the requirements for Proclamation 20-12.5: Higher Education, which removed the philosophical exemption option for students. Consistent with the proclamation, Grays Harbor College is a fully vaccinated campus and is implementing a policy requiring all of its students who participate in or attend courses, operations, or other activities in person to be fully vaccinated against COVID-19, subject to any medical exemptions required by law and any religious exemptions.

INSTRUCTIONS FOR STUDENT

By October 4, 2021, all students seeking an exemption must select the medical or religious exemption option in the student vaccination attestation form. Students who do not effectively start this process by that date will be removed from in-person classes and not allowed on campus.

By November 5, 2021, in order to grant a reasonable accommodation to a student to remain unvaccinated, Grays Harbor College must receive documentation from a Health Care Provider, as defined below. That documentation must confirm that the student is medically unable to receive an authorized COVID-19 vaccine. The documentation must also include a duration the accommodation will be needed.
